Persons Eligible for the Grant and the Amount of the Grant

1. Indo-Chinese Refugees and their family members

* "Family members" in this context mean those who finished the courses in the Himeji or Yamato Resettlement Promotion Center or the International Refugee Assistance Center.

2. Those who are recognized as refugees by the Minister of Justice (Convention Refugees) and their family members

* "Family members" in this context mean foreign nationals residing in Japan who have not been recognized as refugees but have been granted the status of residence as family members of Convention refugees. In principle, they are limited to spouses, parents and children including adopted children of Convention refugees.

Note 1. Those who have been granted other scholarships, school expense subsidies or welfare benefits may also apply for this grant. Those who are schooling several schools at same time, the grant will be granted for only one school. There might be reducing of provision of support or breaking off of grant on the way of fiscal year if the amounts of grants are exceeded the grant budget.

2. Convention refugees and their family members may also: (1) within one year after finishing the course in the RHQ Support Center; (2) within one year after being recognized as refugees; or (3) within one year after entering Japan.
3. Professional training colleges and other educational institutions including institutions for Japanese language education in this context means educational institutions, which offer courses of more than 6 months (5 days a week). Classes given by voluntary organizations are excluded.
4. In order to conduct research on the periods needed for finishing courses and the contents of classes, we may ask you to submit additional documents such as school regulations.
